VII Environmental Health Service Report (Supplee)

Rebecca Supple has accepted the permanent position of Program manager for the Hazardous Materials Program. Dr. Leff, Santa Cruz County Health Officer will continue to serve as the Director for Environmental Health. The hazardous materials program has 3 new vehicles to replace aging vehicles used for inspections. Environmental Health site mitigation staff will be meeting with the Regional Transportation Commission in early June to finalize an agreement for Environmental Health to provide oversite of all projects along the rail corridor that involves excavating in areas where the soil are likely contaminated. Arsenic is the primary chemical of concern along the rail corridor.
